Some things should be settled immediately after a loved one passed away, even before the funeral. Other things can wait, a couple of days, even weeks or months. The general checklist below shows what needs to be done and when, at a glance.

### Immediately after passing (before the funeral)

Call the doctor on duty

Contact the funeral home

Contact funeral insurance company

Check the testament / will (if funeral wishlist is included in the will)

Check the donor registration

Arrange death certificate

Contact and inform important person(s)

Arrange clothing

## Funeral checklist

---

### Just after the funeral

- Contact notary for will
- Inform bank(s)
- Arrange new authorization (accounts)
- Inform employer
- Inform funeral insurance company, SVB
- Apply for survivor's/ orphan pension
- Inform authorities (health insurance company, SVB, tax authorities, utility companies.)

### Within a few months

- Arrange custody (child benefits, study funding)
- Inventory of automatic transfers (creditcards)
- Inventory of bank balances
- Inventory of debts
- Inventory of possessions
- Collect insurance money
- Open the safe deposit box
- Securities and real estate property check
- Distribute estate

Besides the huge grief, death also has financial consequences. For example, think of the cost of a funeral, or the loss of a portion of income. In addition, all kinds of practical matters must be taken care of, such as the cancellation of current and/or savings accounts and cashing policies. In this chapter you will find out more about your finances.

It is recommended to keep proof of ownership/ debt in one central place.

### Bank

After a loved one passed away, it is recommended to contact the banks to cancel accounts and/or credit cards. The bank will block the account immediately. All power of attorney signed by the deceased will automatically expire. However you can still make payments for the following providing an invoice; funeral expenses, hospital bills, utility bills.

It is safer to NOT write down any PIN numbers or passwords in this booklet. However do provide this information to your loved ones where they can access this information.

Even after you pass away, you remain present with those you love, in what you leave behind. Many people don't talk or think about it while they are still here, and that's understandable. Therefore it is good to write down some of your wishes. So the bereaved know exactly where they stand.

## My inheritance / Health Care Confidential

### Other important documents to have in one place

- Letter of instructions
- Financial power of attorney
- Personal & medical history
- Durable health care power of attorney  
(Allows you to name a person to direct your health care when you cannot do so)
- Authorization to release health care information
- Living will  
(You describe what medical care and treatments you do or do not want to receive)
- Do not resuscitate order  
(A NTBR form is a specific document that must be signed by the patient, and alerts the medical staff that in the event that your heart stops beating or you stop breathing, your desire is to not be reanimated)
